Sir/Madam,

I am directed to forward herewith a list of officers working in your Ministry/Department appointed as Assistant Supervisors/Invigilators for the conduct of the examination mentioned above. The place of duty has been indicated against each name. I am to request that the services of the officers concerned may kindly be spared on the date specified and they may be instructed to report to the Venue Supervisor on the day of examination at the time indicated below. Under no circumstances should an officer be allowed to withdraw from Supervision /Invigilation duties without the Ministry/Deptt. making alternative arrangements. Changes in Supervision/Invigilation arrangements, if any, should be reported to the undersigned immediately. However, changes which occur within a week of the date of the examination should be reported to the Venue Supervisor concerned directly through the officer nominated for duty. A copy should be endorsed to the Commission also for information and record.

2. The officers concerned may kindly be informed that in case any one of them absents himself/herself from Supervision/Invigilation duty without timely prior intimation to the Union Public Service Commission or arrives at the Centre late or is reported by the Venue Supervisor to be non-cooperative or found negligent in his/her duty or his/her performance is otherwise reported to be unsatisfactory, his /her name will be removed from panel of the Asstt.supervisor/invigilator maintained by the Commission. Further, suitable action may also be initiated against such Officers.

3. The Assistant Supervisor will be paid remuneration @ Rs. 900/- per session and Invigilator will be paid remuneration @ Rs. 800/- per session for the actual day of the examination at the designated venue.

4. If any of the Officers, whose services as Assistant Supervisor(s)/Invigilator(s) have been requested for, has any dependent/relative appearing at the above-mentioned examination at the Delhi Centre, he/she may kindly be asked not to accept the offer of appointment. Similarly, if at any stage, even after accepting the offer, an officer, appointed as Assistant Supervisor/Invigilator finds that any dependent/relation of his/her is a candidate for the examination at Delhi Center, he/she may kindly be asked not to take up the assignment.

5. CDS (I) Examination 2025 will be held on 13th April 2025 (Sunday) in two/three sessions at Sub Centre No. 001 to 054. Three sessions will be in Sub Centre No. 001 to 027 only. From Sub Centre 028 to 054, there will be only two sessions.(1st & IInd session). The time table for the CDS (I) 2025 examination is as under-

1st Session 09.00 A.M. to 11.00 A.M.

2nd Session 12.30 P.M. to 02.30 P.M.

3rd Session 04.00 P.M. to 06.00 P.M.

(Reporting time for Assistant Supervisors and Invigilators - 07.00 A.M. sharp)

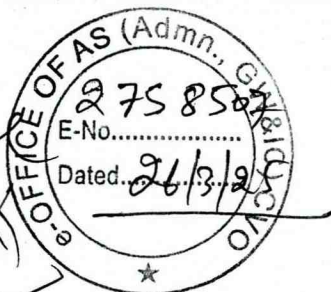
