## **CIRCULAR**

Subject- Regarding removal of eligibility criteria of upper age limit for appearing in JSA/LD Grade LDCE 2024, SSA/UD Grade LDCE 2024 and opening of exam window-reg.

This is to inform that in exercise of powers conferred under Rule 24-A of CSCS Rules, 1962, DoPT has provided relaxation in the eligibility conditions of upper age limit for enabling candidates of MTS (who form feeder grade of JSA of CSCS) and JSAs of CSCS for appearing in JSA/LD Grade LDCE 2024 and SSA/UD Grade LDCE 2024 respectively. Also, relaxation of one year has been granted in regular qualifying service of MTS upto Select List Year(SLY)-2019 to enable their participation in JSA/LD Grade LDCE 2024.

2. In this regard, Staff Selection Commission vide its addendums dated 02.05.2025 (No. E/10/2025-C-2 Section in respect of JSA/Lower Division Grade Limited Departmental Competitive Examination 2024 and SSA/Upper Division Grade Grade Limited Departmental Competitive Examination 2024 separately, has opened window for inviting application forms from the eligible employees of CSCS cadre for the said examinations.
