- 3. In this regard, it may kindly be noted that the upcoming one-week *In-Service Training Programme* on "Shaping the Future of Environmental management" being organized by IIM Indore, Indore from September 22, 2025 to September 26, 2025. This programme aims to strengthen participants' understanding of environmental economics, sustainability science, and environment-related public policy.
