2. The terms and conditions for the above-mentioned training programme would be as under:

  - d. Md. Naseem, US shall be required to submit the certificate of examination passed.
  - e. On completion of the course, Md. Naseem, US will report back to CS. I Division, Department of Personnel and Training, for further posting.
