

**Minutes of the meeting held under the Chairmanship of Deputy Secretary (WR, RD & GR) regarding the Public Disclosure Portal of UPSC on 28.01.2025**

A meeting was held under the Chairmanship of Deputy Secretary (Admn.) on 28.01.2025 in his Chamber regarding dissemination of information regarding the Public Disclosure Portal of UPSC and exploring the potential of the portal in appointments under Autonomous Bodies, Statutory Bodies and Public Sector Undertakings. List of participating officers is attached at **Annexure-I**.

2. Deputy Secretary (Admn.) welcomed all the participants of the meeting and apprised them about his attending the workshop in UPSC on behalf of this Department on 17.01.2025 regarding the Public Disclosure Portal of UPSC. Deputy Secretary (Admn.) informed all the participants that UPSC is publishing the details of the non-recommended (candidates who qualify the written examinations but are not recommended after the interview) willing candidates of the Examinations conducted by the UPSC under the Public Disclosure Scheme (PDS) on its Website.

3. The participants were informed about the procedure of registration, potential and scope of the portal alongwith the benefits of screening of prospective candidates through the portal for appointments in Statutory Bodies/Autonomous Organisations/Attached Bodies and Public Sector Undertakings. DS (Admn) requested all the representatives of SMDs to take up the matter with concerned organisations under their administrative purview to get the eligible organisations registered on the portal and to utilise the pool of 26000 willing candidates uploaded on the UPSC's PDS portal.
