PROGRAM OVERVIEW

India's water sector is both complex and vital to national development. The Ministry of Jal Shakti, through its departments, institutions, and flagship schemes, undertakes a wide spectrum of activities—from resource assessment and infrastructure planning to policy-making and river basin governance. While technical officers handle specialized functions, non-technical officers (e.g., Directors, Deputy Secretaries, Under Secretaries, Section Officers, ASOs, and Private Secretaries) play an essential role in supporting these efforts.

To strengthen their domain understanding, the National Water Academy (NWA), CWC, Pune has been organizing a dedicated training program titled **Overview of Water Resources**Sector of India' since 2013. Designed for non-technical officers of the Ministry, including those from the DoWR, RD & GR and Central Water Commission, the program bridges the knowledge gap between administrative and technical domains.

The program enhances awareness of water governance, key policies, flagship schemes (such as the National Water Mission, PMKSY, Namami Gange, Jal Shakti Abhiyan, NHP, DRIP etc), and sectoral challenges like climate variability, groundwater depletion, and inter-basin conflicts etc. The program is designed to enhance and core and functional competency skills of a non-technical officers to align their administrative roles with the Ministry's broader mission and vision for effectively discharging the responsibilities.

- Environment, Social and Economic Aspects of WRPs
- Field Visits to nearby Water Resources Projects, Labs etc.
