## Pradhan Mantri Rashtriya Bal Puraskar (PMRBP)

#### 1. Overview

The Pradhan Mantri Rashtriya Bal Puraskar (PMRBP) is a national-level award conferred annually by Hon'ble President of India to recognise the exceptional achievements of young individuals (below 18 years as on 31 July 2025) across multiple fields

#### 2. Objectives

- To celebrate and amplify the achievements of India's youth in diverse spheres.
- To inspire peers nationwide by showcasing real-life role models.
- To foster an enabling environment for children's holistic development

#### 3. Award Categories

PMRBP is conferred in six categories- Bravery, Social Service, Environment, Sports, Art & Culture and Science & Technology

## 4. Eligibility & Nomination Process

- Age Criterion: 5 18 years (as on 31 July, 2025)
- Who Can Nominate: Any individual or institution may nominate children with exceptional achievements for PMRBP. Children may also apply through self-nomination
- Nomination on Rashtriya Puraskar Portal: <a href="https://awards.gov.in">https://awards.gov.in</a>
- Last date of Nomination: 31st July, 2025

## 5. Steps to Fill the Nomination Form

## i. Register/Login:

- o Visit https://awards.gov.in
- o Click on "Login/Register" on the top-right corner.
- Fill in details: First Name, Last Name, Date of Birth, Applicant Type (Individual/Organisation), Mobile Number, Email ID, Aadhaar Number, etc.
- Enter the CAPTCHA and click "Submit".

#### ii. Filling the Application Form:

- After login, click on "Pradhan Mantri Rashtriya Bal Puraskar 2025" under the Ongoing Nominations section.
- o Click on "Nominate/Apply Now" at the top-right corner of the page.
- Select the relevant Award Category.
- Choose whether you are nominating yourself or nominating someone else.
- Provide Nominee's details and achievement information.
- Upload:
  - Supporting documents (PDF format, up to 10 attachments)
  - Photograph (jpg/jpeg/png,)
- Write a concise narrative (max. 500 words) detailing the nominee's achievement and impact.

#### iii. Save & Edit:

- Applications can be saved as drafts before submission.
- To continue later, log in and go to the "Submitted Nominations" tab, then select "Edit" to resume.

#### iv. Final Submission:

- Review the application thoroughly.
- Once satisfied, submit the application. A downloadable copy will be available post-submission.
