Subject: Timely Response to Proposals Circulated for Comments – Health Ministry's Screening Committee (HMSC)

Dear Ms. Mukherjee,

The Health Ministry's Screening Committee (HMSC), chaired by the Secretary, Department of Health Research, Ministry of Health and Family Welfare, is the nodal body for screening health research projects involving foreign assistance and/or collaboration from non-governmental entities.

It has been observed that proposals circulated to member ministries/departments for their comments are sometimes held up for several weeks or months due to delays in receiving comments. Since research activities are time-sensitive and delays may adversely affect funding and initiation of the research, it is requested that comments on such proposals be provided within four weeks of receipt.

In case additional time is required, the concerned Ministry/Department may inform the Secretariat citing specific reasons for the delay. If no response is received within the stipulated time, the HMSC will assume that there are no comments and proceed with decision-making accordingly.

The cooperation of all concerned Ministries/Departments in ensuring timely processing of research proposals for international funding and collaboration is sincerely appreciated.
