Applications/ Nominations are invited from eligible persons for the post of Joint Director, Central Institute of Educational Technology (CIET), New Delhi, a constituent unit of the National Council of Educational Research and Training (NCERT) having the Pay Scale of Rs. 1,44,200 - 2,18,200/- (Academic Level-14) (pre-revised Pay Band of Rs. 37,400 to 67,000/- (PB-4) with Academic Grade Pay Rs. 10,000/-). The Joint Director, CIET, New Delhi works within the overall parameters of NCERT. His/Her duties include undertaking, guiding and coordinating all aspects related to Educational Technology and mass media, including research, curriculum development and training.
