This is in continuation of our earlier letter referred above on the subject. In this regard, it is to state that under the Mission Karmayogi, Capacity Building Commission (CBC) is mandated to assist Departments to develop Annual Capacity Building Plan to document the capacity building needs of the department related to domain, functional and behavioral competencies; and to identify both training and non-training interventions to bridge the capacity / training needs.


CBC undertook Capacity Need Analysis (CNA) for the Department of Water Resources, RD & GR and its organizations and based on the CNA, prepared an Annual Capacity Building Plan for DoWR, RD & GR. As per the CNA exercise conducted to capture top five competency requirements, “**International convention/ laws of Water**” emerged as one of the top priority ‘Domain competency’ for the officials of DoWR, RD & GR and its organizations. CBC suggested to have one week course(27 hrs) on the subject of “**Water Law and River Valley Disputes**” to cover and enhance the competencies of the officials in the identified domain area. NWA, CWC, Pune has been identified as a training provider to conduct this course in off-line mode.

As a follow-up for the implementation of ACBP, NWA, CWC, Pune has conceptualized and formulated five days training program on “**Water Laws and River Valley Disputes**” specially for the officers of DoWR, RD & GR and its organizations, earlier scheduled to be conducted during **17-21 March, 2025 has now been rescheduled during 26-30 May, 2025**. The program is designed with an objective to develop the core competency in ‘**International Convention /Laws of Water**’.

An information bulletin giving details of the program is enclosed as ready reference. INTRODUCTION & BACKGROUND

Increasing water scarcity is one of the greatest challenges for our country. As local demand for water rises above supply in many regions, the effective governance of available water resources will be key to achieving water security, fairly allocating water resources and settling related disputes. Cooperation on inter-state/internationally shared water resources is also critical, especially in water-scarce regions where the upstream and downstream impacts of consumption and pollution are magnified.

India has comprehensive legal frameworks governing water resources and the associated challenges arising from river valley disputes. With India's diverse geography and competing water needs, understanding the legal aspects of water management is crucial for sustainable development and conflict resolution.

Water Laws/Governance refers to the political, social, economic and administrative systems in place that influence water's use and management. It determines the equity and efficiency in water resource allocation and distribution, and balances water use between socio-economic activities and ecosystems. Governing water includes the formulation, establishment and implementation of water policies, legislation and institutions, and clarification of the roles and responsibilities of government, civil society and the other stakeholders in relation water resources management.

India shares its boundaries with Pakistan, Afghanistan, china, Nepal, Bhutan, Mynmar and Bangladesh. Some of the river systems of the world (e.g. Ganges, Indus, Brahmaputra) are in this subcontinent and all these river systems are transboundary. In case of Indus & Part of Ganges & part of Brahmaputra, India is upper riparian and it is lower riparian in part of Ganges & part of Brahmaputra. So international co-operation is vital in Indian context also for development and management of these river basins.

This training program seeks to equip participants with a comprehensive understanding of India's water laws and the mechanisms for addressing river valley disputes. Participants will delve into the intricacies of water governance, legal frameworks, and strategies for effective dispute resolution. It also covers International matters. The objective is to foster expertise among professionals, policymakers, and stakeholders to navigate the complexities of water-related legal issues and promote sustainable water management practices

LOCATION
