Dear Secretaries,

The National Commission for Women in pursuance of its mandate under Section 10(1)(d) of the National Commission of Women Act, 1990, to review legal and constitutional safeguards pertaining to women, decided to review "**Cyber Laws affecting Women**" in the year **2024-25**. During these consultations one of the major recommendations proposed by these experts was the immediate need of conducting mass awareness to protect women from all types of cyber offences.


