- **2** . The 13 officers mentioned at S.No. 1 to 13 in the above tablehave been sanctioned the follows:
 - a. Air Travel: Rs 1.5 lakh per person/ or as per actual whichever is low.
 - b. **Daily Allowance:** US\$ 1800 each (@ \$150 per day for 12 days) to be arranged by the Indian Mission in Canada subject to condition/instant instruction issued by Government of India on TA/DA admissibility. Further if breakfast and dinner is being provided by the Hotel or Concordia University, the daily allowance will be reduced accordingly.
 - c. Airport Tax/Visa Fees: As per actual.
 - d. **Registration Fee:** CA\$ 19575 per person to be paid toConcordia University
- 3. The expenditure in respect of Central Government officials (S. No.1 to 13) will be borne under FTE component of CWC viz 270180800170112(FTE-EAP) 270180800170212(FTE-Domestic), in the ratio of 50% under each head under DRIP-II for Financial Year 2025-26.
- 4. The Expenditure such as Registration fee, Air Travel, Daily Allowance, Mobile and Airport Tax/Visa Fees/Health Insurance, etc., in respect of officers mentioned at S.No. 14 to 27 of the table above shall be borne by their respective /State Govt./Organization/Implementing Agency/Academic Institutes.
- 5. The deputation of officers at S. No. 14 to 27 for the aforesaid training programme would be subject to vigilance clearance from their respective State Govt./Organization/Institutes.
- 6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad

under any circumstances beyond the above-mentioned approved period without the prior sanction of the Government of India.

- 7. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed thereunder.
- 8. The officers shall submit a report about their visit to the Ministry of External Affairs (AMS Division) and the Department of Water Resources (EA & IC Division) within one month of their return to India.
