ORDER

Subject: Deputation of 04 officers from DoWR RD&GR to attend the 39th meeting of Joint Expert Team (JET) between the Government of India (Gol) and the Royal Government of Bhutan (RGoB) proposed to be held during 08th to 09th October, 2025 at Paro, Bhutan (excluding travel time)-regarding.

Sanction of the Competent Authority is hereby accorded for the visit of the following 04 officers of this Department to attend the 39th meeting of Joint Expert Team (JET) between the Government of India (GoI) and the Royal Government of Bhutan (RGoB) proposed to be held during 08th to 09th October, 2025 at Paro, Bhutan (excluding travel time):

- i. Shri Subhrangshu Biswas, Chief Engineer (T&BDBO), CWC, Kolkata Team Leader;
- ii. Shri Shashank Bhusan, Superintending Engineer (HO&IC), CWC, Guwahati Member:
- iii. Shri Manish Kumar, SJC (B&B), DoWR, RD&GR Member;
- iv. Shri Nitin Kumar, Executive Engineer, BID, CWC, Phuentsholing Member-Secretary.
- 2. The officers mentioned above from DoWR RD&GR are sanctioned the following:
 - i. To & Fro (Air fare) charges from Delhi/Kolkata/Bagdogra to Paro, Bhutan : As per entitlement.
 - ii. **Daily Allowance**: @ US\$ 100 for 2 days (each officer)
 - iii. **Conveyance**: Internal travel is to be arranged by Indian Embassy in Bhutan and raise bills as per rules.
 - iv. **Hotel Accommodation**: As per entitlement, to be arranged by Indian Embassy in Bhutan and raise bills as per rules.
 - v. Airport tax/health insurance/visa charges: As per actual.
 - vi. **Mobile phone**: To be arranged by Indian Mission and raise bills as per MoF Circular No. 24(1)/E.Coord./2010 dated 21.7.2010.

- vii. Gift/pool gifts with packing charges to be presented to Bhutanese delegation @ 4000/- per Team Leader and @ 2500/- for 9 members including packing and carry bags charges.
- viii. Excess baggage charges = Rs. 25,000/-
- ix. Contingency for leader of Indian delegation: Rs. 10,000/-
- 3. The estimated expenditure in respect of four officers of DoWR, RD&GR/CWC in Indian delegation (including airfare, per diem allowance, gifts, excess baggage charges and the Contingency) will be born under FMBAP (Central Water Commission). The expenditure relating to TA/DA in respect of officials of DoWR,RD&GR/CWC to be charged under 2711-01-001-32-00-12-FTE and expenditure other than TA/DA is proposed to be charged under 2711-01-001-32-00-13-Office Expenses(OE).
- 4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of the Government of India.
- 5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
- 6. The officers shall submit a report about their visit to the Ministry of External Affairs (Northern Division) and Department of Water Resources (EA & IC Division) within one month of their return to India.
- 7. This issues with the concurrence of IFD of DoWR, RD& GR vide their IFD's Diary Number: 394/IFD/2025-26 dated 06.10.2025.
- 8. The participation of all the officers shall be subject to clearance from concerned vigilance authority.
