## **ORDER**

- 4. The resignation or request for voluntary retirement from service while abroad shall not be entertained under any circumstances. The officer shall not stay abroad beyond the above-mentioned period under any circumstances without the prior sanction of Government of India.
- 5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Order printed there under.
- 6. The officers shall submit a report about their visit to Ministry of External Affairs (Central Europe Division) and Department of Water Resources, RD & GR (EA&IC Division) within one month of his return to India.

- 7. The visit is being treated as personal visit as per DoE guidelines vide OM No.4(4)/E.Coordl2015 dated 5th Jan 2016. Therefore, the officer shall **take leave** for the period of the visit.
