Bhaskar B Saikia, Sr. Joint Commissioner (CADWM) will be charged from Major Head No. 3451.00.090.16.01.12 of DoWR, RD & GR (Secretariat proper) FTE for the year 2025-26. The Expenditure such as Air Travel, Daily Allowance. Mobile and Airport Tax/Visa Fees/Health Insurance etc. in respect of officers mentioned at S.No. 3 to 5 mentioned above shall be borne by their respective Ministry/State Govt./Organization.
- 4.
