5. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed thereunder.

6. The officer shall submit a report about his visit to the Ministry of External Affairs (Central Europe Division) and the Department of Water Resources, RD&GR (EA & IC Section) within one month of their return to India.
