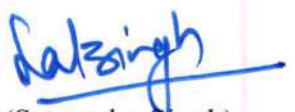
6. The entry of Team/Double event, partner should be from their respective Team only. Players from other teams will not be allowed in Double and Team Events.

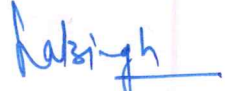
