3. In view of the above, all Organizations / Wings / Divisions / Sections are once again requested to take necessary action for the disposal of VIP / PMO references pending beyond 30 days. In cases where requisite action has already been completed, the same may kindly be updated and marked as disposed off on the VRMS Portal at the earliest.
