- 4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
- 5. The officials shall travel on official passports and shall submit a tour report to Ministry of External Affairs (East-Asia Division) and the Ministry of Water Resources (EA Division) within one month of their return to India.
