4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.

6. The officials shall travel on official passport and shall submit a tour report to Ministry of External Affairs (UNES Division) and the this Ministry (EA &IC Desk) within one month of his return to India.


