ORDER

Subject: Visit of Shri A.K.Jain, Scientist D, CGWB, West Central Region, Ahmedabad, Gujarat to Xi'ann, Peoples Republic of China during 14<sup>th</sup>-25<sup>th</sup> November, 2016 (excluding travel time).

Sanction of the competent authority is hereby accorded to the deputation of Shri A.K.Jain, Scientist D, CGWB, West Central Region, Ahmedabad, Gujarat to attend two week training course i.e. from 14<sup>th</sup> November to 25<sup>th</sup> November' 2016 (excluding travel time) on the "Assessment of Groundwater (CGWB) by using Isotope and Related Techniques" at Xi'an, Peoples Republic of China.

2. All the expenses related to above training course will be borne by the International Atomic Energy Agency (IAEA). There will be no cost to be borne by Govt of India on this training.
3. The officers shall travel on diplomatic/official passports.
4. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
6. The officer may submit a report about the visit to Ministry of External Affairs (East Asia Division) and Ministry of Water Resources, RD&GR within one month of their return to India.
