ORDER

Subject: Deputation abroad of Shri Anuj Kanwal, Member Secretary (INCSW), Indian Committee of ICID and Director, Central Water Commission for participating in 2nd WIF and 67th IEC meeting of ICID to be held during 06th -12th November 2016 (excluding travel time) in Thailand.

Sanction of the competent authority is hereby accorded to the deputation of Shri Anuj Kanwal, Member Secretary (INCSW), Indian Committee of ICID and Director, Central Water Commission for participating in 2nd WIF and 67th IEC meeting of ICID to be held during 06th - 12th November 2016 (excluding travel time) in Thailand.

2. The above mentioned official is sanctioned the following:
 - (i) **Air Passage:** As per entitlement
 - (ii) **Registration Fee:** US \$ 750
 - (iii) **Hotel Accommodation:** US \$1760 (@US \$220 per day for 8 days)
 - (iv) **Daily Allowance:** US \$600 (@US \$75 per day for 8 days). The official can draw the DA either in India (MoWR, RD&GR) or from Indian Mission at Thailand.
 - (v) **Airport tax/health insurance:** As per actual.
3. The above expenditure in respect of Shri Anuj Kanwal may be charged to CWC's chargeable head 80.003-Trg.01.00.12-FTE (NP) for the year 2016-17.
4. The official shall not stay abroad beyond 5 working days. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above mentioned official will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O. M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The official will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
6. The official shall travel on official passport and shall submit a tour report to Ministry of External Affairs (Southern Division) and the Ministry of Water Resources (EA Division) within one month of his return to India.
7. This issues with the concurrence of IFD of MoWR, RD&GR vide their Diary No. 112/IFD/2016 dated 27/10/2016.


