OFFICE MEMORANDUM

Sub: Review of instructions for retention of general pool residential accommodation to retired officers/Judges of Hon'ble High Court of Delhi and Hon'ble Supreme Court.

The undersigned is directed to invite attention to the Directorate of Estates O.M. of even number dated 11.12.2015 vide which retention of general pool residential accommodation from various pools was permitted to retired officers/Judges of Hon'ble High Court of Delhi and Hon'ble Supreme Court on their appointment as Chairmen/Members in eligible quasi-judicial bodies and OM No. 12017/1/76-Pol.II dated 4.8.2008 vide which housing entitlement for officers re-appointed after superannuation from Government service were decided. The matter has been reviewed and it has been decided that retention of General Pool Residential Accommodation to retired officers/ Judges of Hon'ble High Court of Delhi and Hon'ble Supreme Court, when they are re-appointed as Chairmen/Member will be granted according to the following guidelines:

- i) The retention of general pool residential accommodation in various pools may be allowed one type below the entitlement of the Officers and Judges of Hon'ble High Court of Delhi and Hon'ble Supreme Court appointed as Chairmen/Member in all the eligible offices in Delhi, subject to maximum of Type VII accommodation.
- ii) The retention of General Pool Residential Accommodation as specified in (i) above would not be allowed in central area (LBZ area).
- iii) The retention of General Pool Residential Accommodation shall not be permitted to those officers appointed as Chairmen/Members in eligible quasi-judicial bodies in Delhi if they have already vacated their accommodation before their appointment and they shall apply afresh in same pool as no dislocation is involved in such cases.

2. This issues in supersession of OM No.12035/2/2015-Pol.II dated 11.12.2015 and OM No. 12017/1/76-Pol.II dated 4.8.2008.

3. The above mentioned modification will be effective from 16.8.2016.

4. This issues with the approval of the competent authority.


