CIRCULAR

Applications are invited for filling up of two (02) posts of Staff Car Driver (Ordinary Grade) in the Ministry of Water Resources, River Development & Ganga Rejuvenation in Level-2 (19900-63200) of the Pay Matrix by absorption. The absorption is to be effected from amongst the regular Driver or Despatch Riders and Group 'D' employees of the Ministry of Water Resources, RD&GR including Attached and Subordinate offices of the Ministry, possessing the following qualifications:-

(A) Educational Qualifications

- (a) Matriculation or equivalent from a recognized Board;
- (b) Possessing a valid driving license for motorcar;
- (c) Knowledge of motor mechanism;
- (d) Knowledge of Hindi or English language;
- (e) Experience of driving a motor car for five years.


Note: The qualification regarding experience is relaxable at the discretion of the Central Government, for the reasons to be recorded in writing, in case of candidates belonging to the Scheduled Castes and Scheduled Tribes, if at any stage of selection, is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

(B) Essential Qualifications for the Driving Test

- (a) Ability to read English numerals and figures;
- (b) Knowledge of traffic regulations;
- (c) Ability to locate faults and carry out minor running repairs;
- (d) Ability to change wheels and correctly inflate tyres.

2. The willing persons fulfilling the above eligibility criteria, who will be relieved from their work by their Organization immediately in case of their selection, may submit their application through proper channel alongwith duly filled bio-data enclosed with the circular and certified copies of relevant documents/certificates pertaining to their educational qualification(s), experience, Driving Licence, etc. to The Under Secretary (Admn.), Ministry of Water Resources, RD&GR, Room No.-424, Shram Shakti Bhawan, Rafi Marg, New Delhi-110001 within 30 days of issue of this Circular. Applications received after due date will not be considered.
