**OFFICE ORDER NO. 846 /2014**

1. The Hon'ble Minister (WR, RD & GR) has allotted the following works to the Hon'ble MoS (WR, RD & GR) :-

- i) Unstarred Questions except those pertaining to inter-state/international matters and rejuvenation of Ganga and other rivers.
- ii) Matters relating to RRR of Water Bodies
- iii) New/ ongoing projects of CADWM
- iv) All establishment matters related to such posts, below the level of Director, which are not delegated to Secretary (WR) or any other authority in the Ministry.
- v) VIP references which are received in the name of Hon'ble MoS (WR, RD & GR) and those received from Hon'ble Members of Parliament and Legislative Assemblies except relating to matters which are dealt with exclusively by Hon'ble Minister (WR, RD & GR). All other VIP references including those received from Ministers of Union or States will be replied by Hon'ble Minister (WR, RD & GR). However, if it pertains to any matter which is dealt with directly by Hon'ble MoS (WR, RD & GR), it will be submitted through Hon'ble MoS (WR, RD & GR)
- vi) Organisational/Establishment matters, except release of Grants-in-Aid, of National Institute of Hydrology (NIH).
- vii) Organisational/Establishment matters, except release of Grants-in-Aid, of Central Soil & Materials Research Station (CSMRS).
- viii) Matters relating to Official Language
- ix) Welfare of SC/STs and issues of minorities in the Ministry and its organisations.

2. Files relating to the following items of work will be submitted to the Hon'ble Minister (WR, RD & GR) through Hon'ble MoS (WR, RD & GR):-


- i) Matters relating of Aquifer Mapping
- ii) Inter Linking of Rivers;
- iii) Release of Grants-in-Aid to National Water Development Authority (NWDA), NIH and revalidation of unspent Grants-in-Aid
- iv) Brahmaputra Board
- v) Farakka Barrage Project
- vi) Flood Forecasting and Border River Management

3. In all other matters not covered under Para 1 and 2 will be directly submitted to Hon'ble Minister (WR, RD & GR).
