Subject: Constitution of the Steering Committee to 'Plan/Monitor/Review the Activities and Progress of Ganga Rejuvenation Mission'

Keeping in view the importance attached to Ganga Rejuvenation, it has been decided to constitute a Steering Committee to 'Plan/Monitor/Review the Activities and Progress of Ganga Rejuvenation Mission' under the Chairmanship of the Secretary, Ministry of Water Resources & Ganga Rejuvenation. The composition and terms of reference of the Steering Committee would be as follows:



3.	Chairman, Central Water Commission	Member
4.	Joint Secretary (Admn.), MoWR,RD &GR	Member

6.	Joint Secretary & Managing Director (NMCG)	Member
7.	Joint Secretary (PP), MoWR,RD&GR	Member Convener
8.	Director (IEC), MoWR,RD&GR	Member

2. The Terms of Reference (TOR) of the Committee will be as follows:-

- i) Overall review of approved Ganga Action Plan. This will include:
 - a) Review of on-going civil works
 - b) Strengthening of present Sewer Treatment Plants (STP) and consideration of proposal for new STPs
 - c) River Front Development (RFD) schemes proposed by State Governments/NMCG.
 - d) Establishment of Effluent Treatment Plants (ETP) at Kanpur, Kashipur & other places etc.
 - e) Insitu development of 'nalas'
 - f) Funding issues including development of PPP model and market for treated waste water
- ii) Facilitating structure and Communication Strategy at NMCG:
 - a) Guiding NMCG for identification and appointment of Transaction Advisor (TA) for carrying out various activities related to preparation of DPRs, development, construction, research and monitoring etc.

- b) Approving monitoring indicators for various activities related to Ganga Action Plan.
 - c) Convening Public outreach, communication, mass awareness and participation programmes.
 - iii) Issues related to establishment of Ganga Knowledge Centre
 - iv) Approving designers for Community Involvement through Ganga Vahini and Ganga Task Force.
 - v) Promotion of area specific natural plants and medicinal plants in the Ganga Basin States in collaboration with FRI, Dehradun.
 - vi) Any other residual matter
3. The Committee would meet regularly for deliberations.
4. This has the approval of Hon'ble Minister (WR, RD & GR).
