The maximum age limit for appointment by deputation shall not be exceeding <u>56 years</u> as on the closing date of the receipt of applications).

For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the Sixth Central Pay Commission has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said Pay Commission except where, there has been merger of more, than one pre-revised scale of pay into one grade with a common grade pay or pay scale and where this benefit will extended only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.
