

**OFFICE ORDER NO.834/2016**

Consequent upon his appointment as Under Secretary on ad-hoc basis in Level 11 in the Ministry of WR, RD & GR w.e.f 06.07.2016 vide this Ministry's Notification No.27/2016 (F.No.A.22012/2/2016-Admn (Pt) dated 16<sup>th</sup> August, 2016 and in terms of Rule 7(1)(A) of Central Civil Services (Revised Pay) Rules, 2016 notified vide Ministry of Finance, Department of Expenditure's Notification No. G.S.R. 721(E), dated 25<sup>th</sup> July, 2016, the pay of Shri Vinod Kumar, on his exercising option under Rule 6(2) of CCS(RP) Rules, 2016 for fixation of pay in the revised pay structure w.e.f. 06.07.2016, is fixed as under :-

6.	Pay after multiplication by a fitment factor of 2.57 as per the Pay Matrix of the 7 <sup>th</sup> Central Pay Commission recommendation.	Rs.77536.9
7.	Level corresponding to the Grade Pay of Rs.6600/- as per the Pay Matrix.	11
8.	Revised Pay in the Pay Matrix w.e.f 06.07.2016 (either equal to or next higher to the amount arrived at Sl. No.6 above.	Rs.77700/-
9.	Date of next increment	01.07.2017
