The 53rd NDC Course at National Defence College, New Delhi is scheduled to commence on 07^{th} January, 2013. The course is of duration of 47 weeks. A few seats at the NDC Course are earmarked for the civilian officers belonging to various Ministries/ Departments.

A better understanding among professionals drawn from different disciplines in the country having divergent backgrounds and value is yet another objective of the course. Visits to important military stations and frontier posts and some foreign countries form integral part of the course curriculum.

- Officers of other Central Civil Services of the rank of Director/Senior Deputy Secretary of a Central Ministry or equivalent who are likely to reach policy making level of Joint Secretary or equivalent having not less than 16 years of completed service. (c)
- Below 50 years of age as on 01.01.2013, with sound physical and (d)
- Excellent record of past performance. (e)
- Clearance from Vigilance and disciplinary angle.
- The officers should not have undergone a training program of 12 weeks or more duration in India during a period of 5 years preceding the date of commencement of this course. Further, the officer should not have undergone a program of training abroad of more than 2 weeks in preceding 2 years, more than 1 month in the preceding 3 years or more than 6 months in preceding 5 years. 5,
