- (v) Air port tax/ health insurance, if any: as per actual.
- 3. Remunaration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed thereunder.
- 4. The above expenditure in respect of the officials at S. No. (1) & (2) may be charged to Nationial Water Mission budget head 2701.80.800.18.00.12 for the year 2016-17 and in respect of the official at Sl. No. (3) may be charged to Grant No. 107, Major Head No. 3451.00.090.16.01.12—Secretariat Economic Services—Secretariat-Ministry of Water Resources-Foreign Travel Expenses of the Ministry of Water Resources, RD&GR for the year 2016-17 and in respect officer at Sl. No. 4 may be charged from 'Foreign Travel' budget at NIH, Roorkee for the year 2016-17.
- 5. The period of absence from the post in India and grant of pay and allowances and counting of increment for the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.
