

TRAINING CIRCULAR

Subject: Group Training Course in "Integrated Basin Management for Lake Environment" to be held in Japan from September 07 to November 07, 2015 under Technical Cooperation Program of the Government of Japan.

The undersigned is directed to state that the Japan International Cooperation Agency (JICA) has invited applications for the above mentioned training program to be held in Japan from September 07 to November 07, 2015 under Technical Cooperation Program of the Government of Japan.

2. The program is designed to strengthen the participants' capacity to apply the concept of Integrated Lake Basin Management (ILBM) for meeting their lake basin management challenges.

3. The applying organizations are expected to nominate those applicants who are technical officers in charge of lake/wetland water management or researchers in water quality and ecosystem management with more than three (3) years of experience in the relevant field. The applicant should be a graduate of university or equivalent; have competent command over spoken and written English; must be in good health (both physically and mentally); must not be part of any type of military service; be between ages of 25 to 40 years.

4. In addition to above, the following information in respect of the nominated officers may please be mentioned while furnishing the nomination:-

- Whether attended any foreign training program in the past? If so, the duration/details thereof;
- Whether cleared from vigilance angle;
- Age;
- Whether working in North East State/J&K;
- A brief in 50-100 words justifying the nomination.



The course covers the cost of a round-trip air ticket between international airport designated by JICA and Japan; travel insurance from the time of arrival in Japan to departure from Japan; allowances for (accommodation, living expenses, outfit and shipping); expenses for JICA study tours and free medical care for participants who may fall ill after reaching Japan (costs relating to pre-existing illness, pregnancy, or dental treatment are not included).
