3. If Indian Embassy/Mission/host does not provide vehicle during the visit, the delegation may avail of shared taxis for local official trips (reimbursable on production of receipt, wherever available).
4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 5.8.1976.
5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
- 6.. The officials shall travel on official passport and shall submit a tour report to Ministry of External Affairs (UNES Division, [soun1@mea.gov.in](mailto:soun1@mea.gov.in)) and the Ministry of Water Resources (EA Wing) within one month of his return to India. It may also be ensured that all other terms and conditions of Cabinet Sectt. OM No.21/1/7/94 dated 30<sup>th</sup> March 1995 are met.
