- (iv) Conveyance: To be provided by Indian Mission in Netherlands and admissible components of internal travel in Netherlands may be reimbursed if not arranged by Indian Mission.
- (v) Hotel accommodation: As per entitlements for 20 days, to be arranged by Indian Mission in Netherlands and raise bills as per rules.
- 3. The expenses on towards course fee covering tuition fee and insurance will be charged to head 2701.80.800.11.00.20 (OAE) for the year 2015-16 and the expenditure on account of air passage, daily allowance, conveyance, hotel accommodation may be charged to under head 2701.80.800.11.00.12 (FTE) for the year 2015-16.
- 4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above mentioned two officials will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O. M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
- 5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt of India.
- 6. The officials shall travel on official passports and shall submit a tour report to Ministry of External Affairs (UNES Division) and the Ministry of Water Resources (EA Division) within one month of their return to India.
