- (iv) Shri Ramjeet Verma, Director (P&D), Central Water Commission, New Delhi


2. The visit is being organized by the World Bank and the organizers will bear the cost of participation including air travel, accommodation, misc travel expenses, etc. in respect of all the above mentioned officials and there will be no cost to the Government of India.

3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above mentioned three officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O. M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.

5. The officials shall travel on official passports and shall submit a tour report to Ministry of External Affairs (UNES Division) and the Ministry of Water Resources (EA Division) within one month of their return to India.
