- 4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The official will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt of India.
- 5. As per the MEA's guidelines for Taiwan, Shri Anuj Kanwal shall not travel on official passport and shall submit a tour report to Ministry of External Affairs (East Asia Division) and the Ministry of Water Resources (EA & IC Desk) within one month of his return to India.
