ORDER

Subject: Deputation abroad of Shri Jagmohan Gupta, Joint Secretary & Financial Adviser, MoWR, RD&GR to short-term training programme in Australia under DFFT Scheme of DoP&T.

Sanction of the Competent Authority is hereby accorded to the deputation of Shri Jagmohan Gupta, Joint Secretary & Financial Adviser, MoWR, RD & GR to attend customised training programme in "Advanced Leadership Programme" organized by Australia-New Zealand School of Government (ANZSOG) during 28th August to 2nd September, 2016 (excluding travel time) in Australia under Domestic Funding of Foreign Training Scheme of Department of Personnel & Training.

2. The entire period of the training programme commencing from the date of departure from India till the return shall be treated as on 'duty' and salary for this period will be paid by Ministry of Water Resources, RD & GR.

3. As mentioned by DoP&T in its DO No. 12037/36/2016-FTC(Trg) dated 06-06-2016, Govt of India (Deptt of Personnel & Training) will bear the expenditure of the training programme, including per diem, accommodation during the course and the cost of airfare from Delhi-Sydney/Melbourne-Delhi sector.

4. Expenses on Overseas Travel Insurance (which includes Medical Expense, Evacuation & Repatriation for a minimum sum of US\$2.5 lakh and Personal Liability for a minimum sum of US\$2 lakh), travel and health insurance, local pre-departure expenses like visa fees, airport taxes and local transport between airport and place of stay within India and abroad etc., shall be reimbursed from the Ministry which may be charged to Grant No. 96, Major Head No. 3451.00.090.16.01.12-Secretariat Economic Services-Secretariat-Ministry of Water Resources-Foreign Travel Expenses of the Ministry of Water Resources, RD&GR for the year 2016-17.

5. The period of absence from the post in India and grant of pay and allowances and counting of increment for the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

6. The resignation or request for voluntary retirement from service while on training abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India. As directed by Cabinet Secretariat's DO letter No. 1/19/2/2014-Cab dated 12-6-2014, a post-visit report should be submitted to DoP&T (Training Division) on the immediate outcome of the visit.

7. This sanction issues with the concurrence of IFD of the Ministry vide their Diary No.53-FD/2016 dated 03.08.2016.
