- 4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
- 5. The officers shall travel on official passport and must submit a report about their visit to Ministry of External Affairs (EW Division) and Ministry of Water Resources (EA & IC Desk) within one month of their return to India.
