## **ORDER**

- 2. The course is sponsored by Government of Singapore, who will provide accommodation, local transport, medical insurances and daily allowance. The expenses on round trip airfare and other travel related charges on the above visit will be borne by Govt. of India and the same may be booked under CWC's chargeable head: 80.003 Trg 01 CWC 01.00.12 FTE (Non Plan) during the year 2016-17.
- 3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the official will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 5.8.1976. The grant of CCA will be regulated in accordance with the provisions of that Ministry's O.M. No.2/3/E.II dated 27.11.1965 as amended from time to time.
- 4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The official will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
- 5. The official shall travel on official passport and shall submit a tour report to Ministry of External Affairs (Southern Division) and the Ministry of Water Resources (EA & IC Desk) within one month of his return to India.
- 6. This sanction order issues with the concurrence of Integrated Finance Division of Ministry of Water Resources *vide* their Diary No.86-IFD/2016 dated 16<sup>th</sup> September, 2016.
