
- (i) Sh M.P. Singh, Chief Engineer (P&D), Central Water Commission, New Delhi

2. The visit is being organized by Govt of United Kingdom and the organizers will bear the cost of participation including air travel, accommodation, meals, misc travel expenses, etc. in respect of all three above mentioned officers.

3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 5.8.1976.

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India. The officers shall travel on diplomatic passport/official passports.


