## **ORDER**

Subject: Deputation abroad of three officials of CWC to Netherlands for training during 29<sup>th</sup> February- 18<sup>th</sup> March, 2016.

Sanction of the President is hereby accorded to the deputation of following three officials of Central Water Commission to attend training programme on 'Managaing Water Organisations' in the Netherlands during 29<sup>th</sup> February- 18<sup>th</sup> March, 2016 (excluding travel time) being organized by UNESCO-IHE, Delft, Netherlands:-

- (iii) Shri Milind A. Panpatil, Deputy Director, Appriasal Dte, CWC, Nagpur
- 2. The above-mentioned officials are sanctioned the following:
- (i) Air passage: As per entitlement.
- (ii) Registration fee: Euro 2775/- per head (to be paid directly to UNESCO-IHE).
- (iii) Study related costs: Euro 30 per head.
- (iv) Student Accommodation: Euro 900 per head (@Euro 45 per night, for 20 days)
- (v) Daily allowance: US\$1850 (@ US\$ 100 per day for initial 14 days and US\$ 75 per day for subsequent six days)
- (vi) Conveyance: To be provided by Indian Mission in the Netherlands and admissible components of internal travel in Netherlands may be reimbursed if not arranged by the Indian Mission.
- 3. The above expenditure in respect of the officials at S. No. (i) & (ii) may be charged to head: 2701 M&MI, 80.003.04 HRD/Capacity Building, 04.01 National Water Academy (Plan) under sub-head 04.01.12 FTE and in respect of the official at S. No. (iii) may be charaged to head: 80.003-Trg, 01.00.12-FTE (Non-Plan) for the year 2015-16.
- 4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above mentioned three officials will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O. M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
- 5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
