ORDER

Subject: Deputation abroad of officials to exposure visit to Japan on Dam Safety and Management Measures related to seismic hazards during 7-11 March, 2016.

The visit is being organized by World Bank and the expenditure including air travel, accommodation, misc travel expenses, etc. will be borne under trust fund administered by World Bank in respect of all the above mentioned officials and there will be no cost to the Government of India/sending organizations.
3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above mentioned officials will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O. M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
5. The official shall travel on official passports and shall submit a tour report to Ministry of External Affairs (East-Asia Division) and the Ministry of Water Resources (EA Division) within one month of their return to India.
6. This sanction issues with the concurrence of IFD of the Ministry vide their Diary No-194 -IFD/2016 dated 04.03.2016.
