**ORDER**

**Subject: Deputation abroad of four officials to Netherlands for training during 29<sup>th</sup> March to 15<sup>th</sup> April, 2016.**

Sanction of the Competent Authority is hereby accorded to the deputation of following four officials to attend short term training course on River Basin Modelling at UNESCO-IHE, Delft, Netherlands during 29<sup>th</sup> March to 15<sup>th</sup> April, 2016 (excluding travel time):-

- a. Shri R. N. Sankhua, Director(BP), Central Water Commission, New Delhi
- b. Dr. D. Gnanasundar, Scientist 'D', Central Ground Water Board (SECR), Chennai
- c. Shri Anmol Sharma, Assistant Hydrologist, Central Ground Water Board (NR), Lucknow
- d. Shri Manoj Kumar, Deputy Director(P&D), Central Water Commission, New Delhi

2. The above-mentioned officials are sanctioned the following:

- (i) **Air passage:** As per entitlement.
- (ii) **Course fee (tuition fee + study related costs + insurance):** Euro 2560.25/- per head to be paid directly to UNESCO-IHE.
- (iii) **Hotel Accommodation:** \$ 3000 per head (@ \$150 per night, for 20 days) to be arranged by Indian Mission in Netherlands
- (iv) **Daily allowance:** US\$1875 per head (@ US\$ 100 per day for initial 15 days and US\$ 75 per day for subsequent 5 days) to be released by Indian Mission in the Netherlands
- (v) **Conveyance:** To be provided by Indian Mission in the Netherlands from the Schiphol to Delft and back to Schiphol and internal travel in Netherlands may be reimbursed if not arranged by the Indian Mission.

3. The expenditure at para 2(ii) above will be charged to OAE head of NHP 2701.80.004.08.02.20 for 2015-16 in respect of the above officials. Expenses on other items other than para 2(ii) above may be charged to head: 3451.00.090.16.01.12-- Secretariat Economic Services--Secretariat-Ministry of Water Resources-Foreign Travel Expenses of the Ministry of Water Resources, RD&GR for the year 2015-16.

4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above mentioned four officials will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O. M. No. 19036/7/73-E.IV (B) dated 5.8.1976.



5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.

6. The officials shall travel on official passports and shall submit a tour report to Ministry of External Affairs (UNES Division) and the Ministry of Water Resources (EA & IC Desk) within one month of their return to India.
