ORDER

Subject: Visit of Sh Ritesh Khattar, Director, CWC to Australia during 29th May to 26th June, 2016.

The sanction of the Competent Authority is hereby accorded to the deputation of Sh Ritesh Khattar, Director, FCA Dte., Central Water Commission, New Delhi to Australia during 29th May to 26th June, 2016 (excluding travel time) to attend hands-on hydro-meteorological and hydrological services training and exposure to scientific methods applied to rainfall forecasts for flood and water availability forecasting.

2. All the funds on travel and living expenses associated with this visit will be borne by Bureau of Meteorology of Australian Government through their Deptt of Foreign Affairs and Trade and no cost will be borne by the Govt. of India.

3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the official will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 5.8.1976. The grant of CCA will be regulated in accordance with the provisions of that Ministry's O.M. No.2/3/E.II dated 27.11.1965 as amended from time to time.

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The official will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.

5. The official shall travel on official passports and shall submit a tour report to Ministry of External Affairs (East Asia Division) and the Ministry of Water Resources (EA & IC Desk) within one month of his return to India.

6. This sanction order issues with the concurrence of Integrated Finance Division of Ministry of Water Resources *vide* their Diary No. 21-IFD(Pt II)/2016 dated 24th May, 2016.


