ORDER

Subj: Deputation abroad of Shri Prabhat Tyagi, Director (E.I/Vig.), WR, RD & GR to short-term training programme in Paris under DFFT Scheme of DoP&T.

Sanction of the Competent Authority is hereby accorded to the deputation of Shri Prabhat Tyagi, Director (E.I/Vig.), WR, RD & GR to attend the short-term training programme on 'Fighting Corruption' at ENA, Paris, France from 28th October to 6th November, 2015 (excluding travel time) under Domestic Funding of Foreign Training Scheme of Department of Personnel & Training.

2. The entire period of the training programme commencing from the date of departure from India till the return shall be treated as 'on duty' and salary for this period will be paid by Ministry of Water Resources, RD & GR.
3. As mentioned by DoP&T in its DO No.12037/14/2015-FTC(Trg) dated 22.6.2015, Government of India (Department of Personnel and Training) will bear the expenditure of the training programme, including per diem, accommodation during the course and the cost of airfare from Delhi-Paris (France)-Delhi Sector.
4. Expenses on overseas travel insurance, local pre-departure expenses like cost of visa fees, airport taxes and local transport between airport and place of stay within India and abroad etc., shall be reimbursed from Ministry of Water Resources, RD and GR which may be charged to Grant No.107, Major Head No.3451.00.090.16.01.12 – Secretariat Economic Services-Secretariat-Ministry of Water Resources-Foreign Travel Expenses of the Ministry of Water Resources for the year 2015-16.
5. The period of absence from the post in India and grant of pay and allowances and counting of increment for the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
6. The resignation or request for voluntary retirement from service while on training abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India. As directed by Cabinet Secretariat's DO letter No. 1/19/2/2014-Cab dated 12-6-2014, a post-visit report should be submitted to DoP&T (Training Division) on the immediate outcome of the visit.

7. This sanction issues with the approval of the Ministry of External Affairs' Dy. No. WI (A)/122/01/2015 dated 11.6.2015 and with the concurrence of IFD of the Ministry vide their Diary No.73/IFD/2015 dated 06.08.2015.
