**ORDER**

**Subject: Deputation abroad of Sh Puskal Upadhyay, AMD, NMCG to Israel during December 28-30, 2015.**

Sanction of the President is hereby accorded to foreign visit of Sh Puskal Upadhyay, Addl Mission Director, National Mission for Clean Ganga, Ministry of Water Resources, River Development and Ganga Rejuvenation to attend a meeting on 'Clean Ganga' at Tel Aviv (Israel) during December 28-30, 2015 (excluding travel time), being organised by Indian Embassy in Israel.

2. Sh Puskal Upadhyay is sanctioned the following:

- (i) **Air passage:** As per entitlement.
- (ii) **Hotel Accommodation:** US\$ 1000 (@ US\$ 250 per day, for 4 days)
- (iii) **Daily allowance:** US \$ 300 (@ US\$ 75 per day, for 4 days)
- (iv) **Conveyance:** To be provided by Indian Mission in Israel and admissible components of internal travel in Israel may be reimbursed if not arranged by the Indian Mission.
- (v) **Airport tax/health insurance:** As per actual.
- (vi) **Mobile phone:** to be arranged by Indian Missions and raise bills as per MoF Circular No. 24(1)/E.Coord./2010 dated 21.7.2010.


3. The entire expenditure on the visit of Sh Puskal Upadhyay may be charged to Grant No. 107, Major Head No. 3451.00.090.16.01.12-Secretariat Economic Services-Secretariat-Ministry of Water Resources-Foreign Travel Expenses of the Ministry of Water Resources, RD&GR for the year 2015-16.

4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above mentioned official will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Deptt. of Expenditure O. M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The official will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.

6. The official shall travel on official passports and shall submit a tour report to Ministry of External Affairs (WANA Division) and the Ministry of Water Resources (EA & IC Desk) within one month of their return to India.


