ORDER

Subject: Deputation abroad of two officials to attend Second Asia Irrigation Forum at ADB Headquarters, Manila, Philippines during November 17-19, 2015.

Sanction of the President is hereby accorded to the deputation of Shri J. R. Boro, Senior Joint Commissioner (SPR), Ministry of Water Resources, River Development and Ganga Rejuvenation to attend Second Asia Irrigation Forum at Asian Development Bank Headquarters, Manila, Philippines during November 17-19, 2015 (excluding travel time).


2. The visit is being organized by Asian Development Bank and the organizers will bear the cost of participation including direct economy air travel, hotel accommodation, subsistence allowance, misc travel expenses as per ADB applicable rules and there will be no cost to the Government of India.

3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above mentioned official will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O. M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The official will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.

5. The official shall travel on official passports and shall submit a tour report to Ministry of External Affairs (Southern Division) and the Ministry of Water Resources (EA Division) within one month of his return to India.

6. This sanction issues with the concurrence of Integrated Finance Division of Ministry of Water Resources *vide* their Diary No.129-IFD/2015 dated 5-11-2015.


