4. Chairman, CGWB mentioned that they have sent proposal for payment of Rs 18 crore(Approx) in respect of procurement of equipments done last year. The proposal of CGWB be examined and finalized expediously.

5. Chief Engineer, CWC gave a presentation on the progress of IWRM study of 10 major River Basins. He informed that Two Proposals for IWRM studies in respect of 10 basins / sub-basins have been finalized with IIT Delhi & CSIRO Australia. Scope of works, staffing etc has already finalized. IWRM study of these Rivers Basin should be carried out on top priority basis. Assessment of surface water and ground water , its utilization pattern, state of river basin health etc should be done in the study.
