



**Minutes of 101<sup>st</sup> Weekly Review Meeting held under the Chairmanship of Hon'ble  
MOS(WR, RD & GR) on 28.12.2016**

The 101<sup>st</sup> Weekly Review Meeting was held on 28.12.2016 under the Chairmanship of Hon'ble MOS (Dr.S.K.Balyan) in which activities of NWM, appraisal of the projects on Western Rivers for full utilization of Indus Treaty, appraisal of projects of PMKSY, GFCC, Brahmaputra Basin and expenditure were reviewed. The following action points were identified for further action :

**Jal Mathan: 3**

Joint Secretary (PP) briefed about the preparedness about "Jal Manthan -3" proposed to be held on 13<sup>th</sup> January 2017 at Vigyan Bhawan. He mentioned that logistic arrangement is being done by NWDA and technical support will be given by CWC. The following points emerged:

- i) For Technical Session on Ecology Improvement, eminent experts who have done good work in this area should be invited.
- ii) For Technical Session on Participatory Irrigation Management, some farmer leaders should be invited for their views. Water User Associations from 2-3 states who have done good work and 2-3 states who have not done good work should also be invited.
- iii) 6<sup>th</sup> Session on Flood Management and Inter State Water Dispute may also be included in the program.

Presentation of NWM should include Goal-wise indicators along-with its benefits.

**Projects on Western Rivers for full utilization of Indus Treaty**

Commissioner (Indus) made presentation on appraisal of the projects on Western Rivers namely Indus, Jhelum and Chinab. As per Indus Treaty of 1960, the Ravi, Vyas and Sutlej rivers water was allocated to India. India can utilize irrigation of 13 lakh hectares from these western rivers. Also there is huge potential for Hydro Power projects. CWC has cleared projects of all the western rivers. There are total ten river projects under western rivers plan where 6852 MW power will be generated. The DPR of Bursar Project will be completed in January, 2017.

**Appraisal of projects of PMKSY, GFCC & Brahmaputra Basin**

Chief Engineer, CWC made presentation on appraisal of projects. He mentioned that field Offices of CWC have been empowered to approve cost escalation upto 20 percent.

- i) Appraisal of projects of PMKSY apart from 99 priority projects should be completed on priority.
- ii) CWC has appraised 25 projects of GFCC. 26 projects of Brahmaputra Basin which are appraisal in CWC may also be done on priority.
- iii) Computerization of these projects be also done on priority.

**Expenditure**

JS&FA briefed about RE-2016-17 and BE 2017-18 and allocation made under various schemes. He indicated that RE for the current year is 4755 crores and BE for the year 2017-18 is Rs.5637 crores.
