Minutes of 107th Weekly Review Meeting held under the Chairmanship of Secretary(WR, RD & GR) on 15.02.2017

The 107th Weekly Review Meeting was held on 15.02.2017 under the Chairmanship of Secretary (WR, RD & GR) in which review of PMO/VIP references, Audit paras, Court Cases, Parliamentary Assurances, progress of various Law/Bills and e-governance activities of the Ministry were done. The following action points were identified for further action:

1. PMO/VIP references

Wing head shall review pending PMO/VIP references in respect of their wings and dispose it off on priority basis. FM, SP, Admn & PR Wing have maximum numbers of VIP references. PMO/VIP references which are more than 90 days old should be disposed off immediately.

[All concerned Wing Heads/SMDs]

2. Audit paras

There are many Audit paras raised by Internal Audit of the Ministry. The position shall be reviewed by the JS (A) for its early settlement. Wherever recovery is to be done, the same may be examined and be effected, if found appropriate.

3. Court Cases

- i. There are 741 court cases of the Ministry pending in various Courts out of which position of 251 cases has not been updated by various Wings/Organization. All concerned SMDs will review position and update them on CCMS.
- ii. There are 7 contempt cases pending in various High Courts. Status of these cases of High Court should be put up to Secretary (WR, RD&GR) by 16th February, 2017.
- iii. Updation of position of Court Cases should be done by all wings/organizations on CCMS. The position should also be reconciled with DS (E-I). Lists of cases pending in Supreme Court/High Court/CAT/NGT pertaining to various Wings/Organizations are enclosed at Annexure-1. CWC, CGWB, CSMRS have maximum number of cases pending for updation. Immediate corrective action may be taken to safeguard Govt interest. The progress of pending court cases will be reviewed in the next Weekly Review meeting.
- iii. Pending cases of Supreme Court shall be monitored closely and timely action be taken to avoid any adverse comments by Hon'ble Court.

4. Assurance

There are 20 Lok Sabha and 32 Rajya Sabha Assurances pending as on 15.02.2017. The wings/SMDs may review Parliamentary assurance pertaining to them and send implementation reports to Lok Sabha/Rajya Sabha Secretariat for their dropping.

5. FBP

Separate presentation on development of FBP as tourist spot be made to Secretary (WR, RD&GR) after obtaining convenient time slot.

6. Progress of various Law/Bills

A DO letter at Secretary (WR, RD&GR) level may be sent to the states which have agreed on National Water Framework law. Matter may be followed up with states who have not sent their views /response.

[JS(PP)]

6. e-governance

- i. Digitization of physical files should be completed in a time bound manner. SMDs wise list of files to be prepared and presented in next review meeting.

- ii. Mobile Apps on PMKSY to be started on priority. Inspection work to be completed by CWC officers in a time bound manner.
