

Minutes of 108th Weekly Review Meeting held under the Chairmanship of Secretary(WR, RD & GR) on 22.02.2017

The 108th Weekly Review Meeting was held on 22.02.2017 under the Chairmanship of Secretary(WR, RD & GR) in which review of CGWB activities such as artificial recharge, procurement issues, rainwater harvesting , Issues of NIH, CWPRS , CSMRS, BCB, BRB, NCA pendency of Court Cases, progress of digitization and Doabia Committee report were done. A presentation on online monitoring of 99 priority projects of PMKSY was also made by Commissioner (SP). The following action points were identified for further action:

CGWB Matters

- i) Artificial Recharge work being undertaken by CGWB under NGMIS needs to be reconciled with MNREGA. Matter may be discussed with concerned JS in M/o-RD to avoid duplication, role of CGWB etc. A presentation be again made in weekly review meeting in which representative of Rural Development may also be called.
- ii) Rain water Harvesting implemented at 5 Airports in India as per design given by CGWB. Civil works carried out by themselves (Airports) as intimated by Chairman, CGWB. The efficacy /functioning of system created be checked and confirmed by CGWB. Photographs of the structures created be forwarded.
- iii) DLWR to be made functional in 3 months time.

- i) The issue of implementation of 7th Pay Commission pay in NWDA, NIH & NERIWALM may be sorted out/finalized on priority in consultation with IFD.
- ii) Finalization of MOU by NIH officers shall be done in a time-bound manner.

Online Monitoring of PMKSY/Key Activities of CWC

- i) CWC need to put all key data/issues such as Hydrological data, data on water quality, flood forecasting, appraisal & monitoring, dam related analysis on online monitoring system. A presentation on the action plan of CWC for these works shall be made in next weekly review meeting.

- ii) Centre & State share components on the finance of PMKSY projects shall be included in the online monitoring system.
- iii) Data on Micro Irrigation potential created shall also be included in the online system.

Dam Safety/DRIP

- i) Draft Cabinet Note for Dam Safety Bill be finalized by 15th March 2017.
- ii) Detailed Inspection system should be put in place. Process for accreditation of inspectors for dam site be defined/finalized.
- iii) Capacity building/Training by accredited inspectors may be conducted at NWA.

- iv) Data being compiled in DHARMA should be in understandable format.
- v) A presentation be made on the progress of DHARMA in one month time.

- ii) Chairman, CWC may call the meeting of Bansagar Control Board for resolving the issues of states share .
